Dear Commissioner Colvin:

We are writing to express our concern regarding recent reports that Social Security beneficiaries may not receive a cost-of-living adjustment (COLA) in 2016. We believe the absence of a COLA would further strain the limited resources afforded to our nation's seniors and we urge the Administration to ensure that seniors receive the resources necessary to support themselves in 2016.

For 80 years, Social Security has been a promise to America's citizens that they could retire with dignity. Seniors have earned their Social Security benefits after a lifetime of hard work, and we have the responsibility to protect this critical safety net for them in their retirement years. COLAs are vital for our seniors to keep up with the rising costs of medical care, prescription drugs, and housing. The absence of a COLA this year would not only harm America's seniors, but would place undue burden on those who support them, including family and care taking professionals.


We also believe strongly that the use of the Consumer Price Index for the Elderly (CPI-E) as the calculation for cost-of-living increases for Americans aged 62 and older as this CPI would more accurately reflect the spending patterns of the elderly than the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W). The CPI-E grows faster than the current COLA calculation on average, due to a larger portion of spending by the elderly on health care expenditures and other items with prices that tend to rise more rapidly. The CPI-E has increased by an average of about 0.2 percentage points faster than the CPI-W or the Consumer Price Index for All Urban Consumers (CPI-U) since 1982.

We greatly appreciate your ongoing commitment to beneficiaries across the country. We urge you to continue advocating for seniors by supporting policies that would include an annual COLA for America's elderly citizens in the future.
